New Mexico's tax season begins Tuesday, January 19, 2016. A TAP account is required to log in to TAP to file and pay.

Personal Income Tax Filers: The state of New Mexico is requesting additional information this filing season in an effort to combat stolen-identity tax fraud and ensure that your hard-earned tax refund goes to the correct person. The Department will ask that you provide information from your driver's license or state-issued identification card. If the information is not provided, there could be significant delays in processing the return.

WHAT CAN I DO IF I CREATE A LOGON?

ALL TAXPAYERS:

Taxpayers who create a Logon will have access to their New Mexico tax accounts. Taxpayers will be able to view their return history, view previous correspondence sent by the Department, and set up recurring payments.

BUSINESSES:

For Businesses, creating a Logon will allow you to file and pay a variety of taxes including Combined Reporting, Combined Fuel Tax and Workers' Compensation Fee.

COMMERCIAL VEHICLE CARRIERS:

Commercial Vehicle Carriers will be able to purchase Weight Distance Permits and IFTA Decals, file and pay for Weight Distance and IFTA taxes, and submit IRP applications.
